Respondent Town of Stockton filed this action in the District Court of Beckham County seeking to enjoin appellant Ritts from maintaining a hog barn on his rural lot. The injunction was sought on the grounds that the barn violated the zoning ordinance, and that no permit had been obtained for such use. An order to show cause was issued, to which appellant filed his verified answer and cross-petition for revocation of the building permit. Appellant also filed a motion for change of venue, which motion was overruled. The court conducted a trial on the issues raised by the petition and cross-petition. The evidence introduced at the trial was submitted under a stipulation that it would constitute the evidence in the case if the motion for change of venue was sustained. Upon the evidence and the stipulation, the court rendered judgment denying the relief sought by appellant and denying the motion to revoke the permit.
